## **Victorian Liberal Government Offers 3D printers for Victorian Schools**

This blocks and prevents the printer from being used for non-educational purposes. 3DG will also provide the product material, training and support to ensure the 3D printers work to their optimum.

Frank Pertile, Managing Director of 3DG commented "We are excited by the announcement made yesterday by Premier Napthine. It validates 3DG's decision many months back to design, engineer and manufacture a 3D printer specifically for schools. We look forward to engaging with the government to ensure that the locally made, best of breed 3DG school printer is chosen to be installed in all Victorian government secondary schools. It will not only be an investment in education, but the re-birth of manufacturing, and jobs creation in Victoria."
